Mavin spent 26 years working for Wysong and Miles Company, while Jack worked for New Home Building Supply for 52 years.

Jack and Mavin lived active lifestyles, and they enjoyed square dancing, playing bridge, gardening and planting flowers, and traveling. They loved to entertain large groups from their church, Presbyterian Church of the Covenant, where they were members since 1963. Jack designed their home in Greensboro and converted their unfinished basement into a popular gathering place where they often hosted groups from their church.
