Shortly before her death, a former student visited Sue, spending a few days with her at the coast. Sue was passionate about traveling and enjoyed doing so with Pat Stacy, her special friend at Glenaire.

Sue enjoyed her move to North Carolina because she could be close to her son's family and her longtime friends Jan and Terry Hardison. Jan accompanied Sue to visit several communities in the Raleigh/Cary area before they decided Glenaire was a cut above the others. After moving into Glenaire, Sue often expressed to friends that her twelve years as a resident at Glenaire were a wonderful culmination of a life well-lived, and she wanted everyone to know just how significant Glenaire was to her.



Sue included her close friends in many meals and celebrations at Glenaire, wanting to share her home with as many people as possible. Early on, she volunteered her apartment as an example to be toured by prospective residents.

Sue also had close bonds with many of the staff members at Glenaire. One called her "Ms. Super-Duper" because she used that phrase in response to those who asked how she was doing on any given day. To many at Glenaire, she has always been and will be "Ms. Super-Duper."

Sue passed away at Glenaire on December 9, 2022, at 83 years old. Sue's legacy will continue to resonate within our community through the positive impact of her generosity. Her commitment to Glenaire will be cherished and honored through the difference this gift will make in the lives of her neighbors.
